2014-022 ART CYCLES CANADA FOR WISHES INFO TO WEBSITE Council members discussed the recent sightings of wolves in the Tsulquate Park area of town and gave direction to staff to contact the local Conservation Officer regarding the wolf sightings and advise regarding the nature of response to the calls.

2. Councillor Marcotte re: Wounded Warrior campaign and Council support.

Councillor Tidbury advised he will attend the reception at the Port Hardy Legion at 7:00 pm Saturday February 15<sup>th</sup> to welcome the runners and say a few words and also attend at the departure from Carrot Park at 6:00 am Sunday February 16<sup>th</sup>.

Council Marcotte discussed the recent cuts from the Federal Budget for Canadian armed forces members and advised the Wounded Warriors Run was a very worthwhile cause to support. He suggested a donation of \$100 from the District Grant in Aid budget and that Councillors and staff be encouraged to make private donations to the Wounded Warriors campaign.

Councillor Tidbury advised he would be voting against a Grant in Aid to the Wounded Warriors as it was a very similar request for funding that Council turned down for the Art Cycles Canada for Wishes request.

 Deputy Mayor Hemphill re: recent Kwakiutl Band logging protest and a letter from the Kwakiutl Band requesting the District of Port Hardy Council and staff distribute information regarding the protest.

Deputy Mayor Hemphill advised Council of an email recently circulated to them with a letter and a pamphlet from the Kwakiutl Band requesting Council distribute information regarding the protest. Deputy Mayor Hemphill advised the request was to distribute the information regarding the protest not a request to support the protest.

Deputy Mayor Hemphill advised Council that the District of Port Hardy is a signatory to the North Island Regional Protocol Agreement between communities on the North Island and local First Nations. The agreement recognizes First Nations aboriginal rights and title to traditional territories and self governance. The purpose of the agreement is to maintain and strengthen relationships between the signatories in a cooperative manner.

Councillor Huddlestan advised she had not received the email and was not aware of the letter, pamphlet or contents of the North Island Regional Protocol Agreement. Other Council members also advised they were not familiar with the details of the North Island Regional Protocol Agreement between communities on the North Island and local First Nations.

Council further discussed the request and topics included past attempts at cooperative efforts with local First Nation Bands, economic factors, ethical pension investments as mentioned in the letter, environmental issues



#### Re: BC Ferries Service Cuts

On behalf of the Skeena-Queen Charlotte Regional District (SQCRD) Board, I am writing in regards to the BC Ferries service cuts and fare increases, announced by the Province of BC on November 18<sup>th</sup>, 2013.

The Board is undivided in its concern over the rising costs and the proposed reduction in ferry services to coastal communities. In many of our communities, affordable ferry service is as necessary as the highway systems to the remainder of B.C. As a vital transportation link throughout the province, BC Ferries has a significant influence on both our local and provincial economies, and is integral to the daily functioning of many of our residents and businesses.

The BC Ferry Coalition, an ad hoc steering committee of allied residents from coastal communities around B.C., has already completed a mass rally in opposition of the cuts and is encouraging B.C.'s coastal residents to write letters to the Premier describing how the proposed service cuts and higher fares will affect their families and communities. For instance, many hotels across the province have already shown concern over the sustainability of their business, as they are seeing an unprecedented amount of booking cancellations brought on by the BC Ferries service cuts.

The coalition is gaining support from an array of coastal residents, as well as local governments, private industry and businesses, chambers of commerce, and other stakeholders. The SQCRD Board strongly supports the BC Ferry Coalition and its continued efforts in opposing the recent BC Ferries service cuts and fare increases.

To date, the SQCRD has been unsuccessful in scheduling a meeting with Premier Christy Clark to further discuss the myriad of problems surrounding this issue. Moving forward, we request that you show your support against the ferry service cuts by:

#### 1. Writing to the Premier

Writing letters to the Premier, requesting that she schedule a joint-meeting with local governments and First Nations to further discuss this issue. Additionally, copy your letters to the SQCRD and the BC Ferry Coalition.

#### 2. Supporting the BC Ferry Coalition

Because the BC Ferry Coalition is actively carrying out valuable work toward opposing the service cuts and fare increases, I would request that each Council or Board support the coalition in its endeavours by conveying their support by way of a resolution or letter to the coalition.





#### FEE FOR SERVICE / HONORARIUMS / GRANTS-IN-AID

POLICY # CP2.7

Approved: July 10, 1996 Last Amended: June 12, 2007

Page 1 of 1

A. Council must in its annual budget allocate funds for disbursement to non-profit groups which would be evaluated on individual merit. The donation may be made in kind or cash.

District advertising of the grants-in-aid policy will be done in May and August for the next budget year.

Requests for grants-in-aid must be made in writing by the September 30<sup>th</sup> for consideration for the next budget year.

Requests will be reviewed upon submission. Individual merit and available funds will dictate Council's decision.

An application for a grant-in-aid will include the following:

- 1) Detail of how the assistance is to be used.
- 2) A recent financial audited statement.
- 3) Detail, if necessary, the use of fund being raised.
- B. Receipt of Late Grant in Aid Application

The Council may consider a late Grant in Aid application only if unallocated funds remain in the Grant-in-Aid Budget.

Requests will be forwarded to the Director of Financial Services for determination of available funding. If funding is available, the DFS will forward the application to Council for consideration.

C. Requests for Discounts on User Rate Fees

The District of Port Hardy will not consider requests for discounts for recreation fees, moorage or any fees that are set by bylaw.

Upon receipt of requests, staff will:


