#### HALLOWEEN FIREWORKS

Bylaw No. 05-2010 regulates the possession and discharge of fireworks in the District of Port Hardy

- A permit must be obtained from the District of Port Hardy for the use of all fireworks including, but not limited to, Class F.1 Consumer Fireworks.
- Consumer fireworks may only be discharged between 5:00p.m. and 10:00p.m. on October 31st (Halloween).
- Permit applications must be submitted to the District of Port Hardy no later than noon on October 31st (there is no fee).
- Permit applications for consumer or display fireworks events must be submitted no later than thirty (30) days prior to the date of the event.

## 2014 MUNICIPAL ELECTION

### INFORMATION FOR CANDIDATES - Who Can Run for Council?

A person is qualified to be nominated, elected, and to hold office as a member of Council if that person meets all of the following criteria:

- is a Canadian citizen;
- is 18 years of age or older on General Voting Day (November 15, 2014);
- has been a resident of B.C. for at least six months prior to filing nomination documents; and,
- has not been disqualified by the Local Government Act or any other enactment from being nominated for, being elected to, or holding office, or be otherwise disqualified by law.

### Nomination Information

Nomination documents for persons interested in running for the office of Mayor, Councillor or School Trustee will be available at the District of Port Hardy Municipal Hall, 7360 Columbia Street, Port Hardy, after 8:30am, Friday, August 29th, 2014.

Nomination documents must be completed in full and filed with the Chief Election Officer or person designated by the CEO, during the nomination period which is from 9:00am on September 30th through to 4:00pm on October 10th, 2014.

### INFORMATION FOR ELECTORS - Who Can Vote?

#### Resident Electors

A person is eligible to vote as a Resident Elector if that person meets all of the following criteria:

- is 18 years or older on General Voting Day (November 15, 2014);
- is a Canadian citizen;
- has been a resident of British Columbia for at least 6 months immediately before registering to vote;
- has been a resident of the District of Port Hardy for at least 30 days before registering to vote; and,
- has not been disqualified by the Local Government Act or any other enactment from voting in an election or be otherwise disqualified by law.

Resident Electors will be required to produce two pieces of identification which provide evidence of identify and place of residence, one of which includes a signature.

#### Non-resident Property Electors

A person is eligible to vote as a Non-resident Property Elector (owner of property in Port Hardy), if that person meets all of the following criteria:

- is 18 years or older on General Voting Day (November 15, 2014);
- is a Canadian citizen;
- has been a resident of British Columbia for at least 6 months immediately before registering to vote;
- has been a registered owner of real property in the District of Port Hardy for at least 30 days immediately before registering to vote;
- is not entitled to register as a resident elector in the District of Port Hardy;
- has not been disqualified by the Local Government Act or any other enactment from voting in an election or be otherwise disqualified by law;
- the only persons who are registered owners of the real property, either as joint tenants or tenants in common, are individuals who are not holding the property in trust for a corporation or another trust; and,
- if there is more than one registered owner of the property, only one of those individuals may, with the written consent of the majority of the owners, register as a Non-resident Property Elector.

A person may only vote once as a Non-resident Property Elector regardless of how many properties that person owns in the District of Port Hardy.

Non-Resident Property Electors will be required to fill out the APPLICATION FOR REGISTRATION AS A NON-RESIDENT PROPERTY ELECTOR IN THE DISTRICT OF PORT HARDY and show proof of ownership of the property (title certificate, current title search, 2014 Property Tax Notice or 2014 Assessment Notice) as well as two pieces of identification confirming identity, one of which includes a signature. If there is more than one registered property owner, a NON-RESIDENT PROPERTY ELECTOR CONSENT FORM MUST BE completed by a majority of the registered owners and submitted.

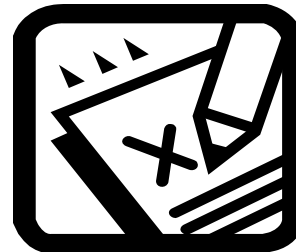
