Request for Quotation

Public Works Yard Fencing Project

The District of Port Hardy is requesting submissions for the supply and installation of a chain link fence around the **Public Works Yard at 8900 Park Drive**, Port Hardy BC.

This is a Request for Quotation only. By requesting quotations, the District of Port Hardy does not intend to enter into, and shall not be considered to have entered into, contractual relations upon the submission of a quotation by any person and no "Contract A" shall be formed between the District of Port Hardy and any supplier upon the submission of a quotation.

Scope of Work

The District of Port Hardy is seeking the services of a qualified fencing contractor to complete the following:

- Removal of the existing chain link perimeter fence;
- Supply and installation of a new chain link perimeter fence.

Specifications

- 460m of 2.43m high, 9-gauge galvanized chain link;
- 2 lockable vehicle gates 6m wide by 2.5m in height;
- All fencing will have 2 barbed wire strands on top;
- All posts will be set /anchored in concrete and spaced every 2.5 meters

Materials

920	Metres	1 5/8" diameter, Commercial top, middle, bottom rails
8	Posts	2 7/8" diameter, Schedule 40-line posts, gate & corner posts
180	Posts	2 3/8" diameter, Schedule 40-line posts

Note: Pipe connections, posts, rails, mesh and fittings on the chain link fence will be galvanized.

Options to be quoted separately

- All rails, posts and gates powder coated black;
- Black mesh.
