## Council News

### Highlights from the Council Chamber

**November 13, 2025**

- Staff directed to prepare a resolution for the 2026 AVICC Convention advocating for no-cost EpiPens for BC residents; resolution to be reviewed at a future meeting.
- Staff directed to send information about the AVICC AGM & Convention Student Participation Program to Port Hardy secondary schools.
- Approved request for six hours of gymnasium time at Port Hardy Secondary School for junior volleyball, starting January 6, 2026, under the Reciprocal Use Agreement.
- Council approved providing a letter of consent to the Gwa'sala-'Nakwaxda-wx Nations for the Tsulquate River Bridge Replacement Project.
- Council resolved to send a follow-up letter to Honourable Minister Joanne Thompson, reiterating the importance of recreational fishing and the impact of Chinook fishery closures on coastal communities.
- Council resolved to send a follow-up letter to Honourable Minister Josie Osborne, requesting that RSV vaccines be made available at no cost for individuals seeking protection against RSV.

**November 25, 2025**

- Council received an update from RCMP S/Sgt. Kimberly Rutherford, including:
  - 0.6% increase in overall file count.
  - Staffing improvements expected to increase traffic and other files.
  - More calls about online issues; new files are being generated.
  - Zero tolerance for public intoxication and an early intervention approach.
  - Success in reducing fights, assaults, and supporting clients accessing care and shelters.
  - Increase in bail violations due to proactive curfew checks.

- Moving violations expected to rise with new check-stop approach.
- Drug trafficking is reported as zero, but cases remain before the courts.
- RCMP staff training and collaboration with Island District General Investigation Section.
- Council received a timeline (April–June 2026) for park works; extension request sent to the estate lawyer for the Lizzie Estate Bequest.
- Staff directed to prepare a congratulatory letter to Connective for being named BC Non-Profit Housing Association Provider of the Year.
- 2026 Regulatory Council Appointments: Council endorsed external regulatory appointments for 2026, including:
  - Mayor Corbett-Labatt and Councillor John Tidbury as Directors for the Regional District of Mount Waddington Board and the Hospital Board.
  - Councillors Dennis Dugas and Janet Dorward as alternates.
- Councillors Treena Smith and Janet Dorward as Trustee and Alternate Trustee for the Vancouver Island Regional Library Board.

- Council resolved to send a letter to MLA Kindy requesting support for the coastal forest sector in response to the Crofton Pulp Mill closure and the urgency of the coastal forest crisis.
- Council resolved to send a letter to the Minister of Housing and Municipal Affairs expressing concerns about Bill M216 and its potential implications for local governments and communities like Port Hardy.
- Council agreed to join other local governments in signing a letter to Premier Eby regarding water insecurity threats to BC communities and the economy.
- Council deferred proposed activities and budget estimates for the Port Hardy 60th Birthday to the Finance Committee for further discussion.
- Bylaw No. 1183-2025 Official Community Plan was adopted as presented.
- Bylaw No. 1186-2025 Revenue Anticipation Borrowing Bylaw was adopted as presented.

### Reasons to license your pet:



Dog licensing using a tag is a quick and efficient way to reunite a lost dog with their owner.

By purchasing a tag, you are letting others know that your dog belongs to someone. Animal Control can then easily identify the owner(s) and reconnect the owner(s) with their lost companion.

The license fee is nominal if the dog is spayed or neutered.

Temporary tags are available for dogs younger than 8 months, FREE of charge.

# Property assessments and property taxes: A not-so complicated relationship



BC ASSESSMENT

## BC Assessment Notices Arrive in January: What Do They Mean for Your Property Taxes?

Each January, property owners receive their BC Assessment Notice, which provides an estimated market value of your property as of July 1 of the previous year. While this notice does not show your property taxes, it plays a key role in how your municipal taxes are calculated later in the year.

## Understanding Your 2026 Property Assessment in Port Hardy

For Port Hardy, the total net assessment change for each class in 2025 was:

Residential total:	2.5%
Single Family	3.4%
Strata	0.7%
Business/Other:	5.2%

Please take a look at the image on the next page to see how this relates to your tax notice.

**⚠ Important:** Assessment increases do not automatically translate into the same percentage increase in taxes—it depends on how your property's change compares to the community average and the tax rates set by all agencies.

## Appealing Your Assessment

You may consider an appeal if you think your assessment is incorrect or unfair, such as when:

- Your property data (size, age, classification) is inaccurate
- The assessment does not reflect market value as of July 1
- Comparable properties are assessed significantly lower without cause
- Your home has condition issues not reflected in the assessed value

## An appeal is not appropriate for concerns about:

- The amount of taxes you pay
- Your ability to pay
- Municipal spending or tax rates

## Deadline to Appeal

If you choose to appeal, you must file a Notice of Complaint with the Property Assessment Review Panel by February 2, 2026. Before filing, BC Assessment encourages property owners to contact their local assessor to discuss their notice—many issues can be resolved informally.

## Spotlight: BC Property Tax Deferment Program — What You Need to Know

Property taxes are a significant part of annual homeownership costs, and many homeowners may benefit from learning about the BC Property Tax Deferment Program. This provincial initiative can help eligible property owners defer payment of their current year's property taxes.

### What the Program Is

The Property Tax Deferment Program is a low-interest loan offered by the Province of British Columbia. When approved, the Ministry of Finance pays your property taxes on your behalf after the due date, and a restrictive lien is placed on your property until the loan is repaid.

### That lien means:

- You may be limited in making specific changes to your property title (such as refinancing, selling, or adding owners) until the tax deferment loan is repaid.

### Interest starts accruing from the later of:

- The property tax due date, or
- The date you applied to defer.

### Two programs to choose from:

- 55 years and older
- Families with children


# UNDERSTANDING THE IMPACT OF A CHANGE IN YOUR ASSESSMENT ON PROPERTY TAXES

Assumes stable tax rates and no changes in the distribution of budget funding between property classes for your taxing jurisdiction and/or any other taxing agency.

## Here is what could happen to your property taxes:

	Your Property's Value Change	Property Tax Impact
1.	 LOWER than Average Change for Property Class	Taxes Likely <b>DECREASE</b>
2.	 SIMILAR to the Average Change for Property Class	Taxes Likely <b>DO NOT CHANGE</b>
3.	 HIGHER than Average Change for Property Class	Taxes Likely <b>INCREASE</b>

## Class 01 – A mixture of residential property types Average Change Example



The Residential property class includes properties like single-family dwellings, townhomes, and condominiums. The average change will be impacted by the magnitude of change for each property type, and how many of each property type there are in your municipality or taxing jurisdiction.

### Example A:



Your property is currently assessed at **\$540,000**, based upon a valuation date of July 1 last year. Your previous assessed value was **\$450,000**. Your property increased **20%** in value, while the average increase for your property class was **30%**.

Since your property value increased **LESS THAN** the average for your property class, you will likely see a **DECREASE** in your property taxes.

Note: this example assumes that there are no changes in the budgetary requirements of your taxing authority and/or any other taxing agency.

### Example B:



Conversely, your property is currently assessed at **\$630,000**, based on a valuation date of July 1 last year. Your previous assessed value was **\$450,000**. Your property increased **40%** in value, while the average increase for your property class is **30%**.

Since your property increased **MORE THAN** the average, you will likely see an **INCREASE** in your property taxes.

Note: this example assumes that there are no changes in the budgetary requirements of your taxing authority and/or any other taxing agency.

### **Nerf on Ice – Zombies Edition**


- Arena transformed for Nerf on Ice – Zombies Edition, with fog, foam darts, and lots of laughter.



## WINTERIZE YOUR PROPERTY!

Temperatures have dropped. Now is the time to winterize your home to avoid the headache and money on preventable repairs.

**Isolate outdoor taps** - Exposed fixtures are susceptible to freezing. Disconnect hoses and isolate taps to limit the risk of water damage.

**Secure skirting around crawl spaces** - Secure skirting to reduce the likelihood of the water lines below your home from freezing and rupturing.

**Don't leave taps running!** - Running taps not only wastes water, it is ineffective at preventing freezing.

Have you noticed a street light flickering? Perhaps you've recently avoided a car-consuming pothole while driving down the road? Or maybe your neighbourhood has a new outdoor swimming pool thanks to a blocked storm drain. Whatever the problem, submitting a service request with the District has never been easier!

Quick and convenient, Q-Alert is an online reporting tool residents can use to let the District know when a municipal service needs attention. How? It's simple:



1. Notice issue
2. Scan QR Code (or visit [porthardy.ca](http://porthardy.ca))
3. Fill in key details about the issue/concern
4. Drop a pin for accuracy
5. Upload a photo for context
6. Click 'create request'

We take it from there, it's that easy! No need to wait until office hours the next day to call to report a concern. Plus, Q-Alert will keep you informed of the status of your request, and you will be notified as soon as it is completed.

### E-GOV NOW AVAILABLE


The District has launched E-Gov. Property owners can view utility and property tax account balances online in real-time and make payments to an account using a credit card.

## Did You Know? Home-Based Businesses Have Special Rules

Did you know that many people dream of becoming their own sellers of wonderful things—homemade food, jewelry, crafts, art, and more—but the very first step should always be a conversation with us at the District office.

Home-based businesses are a great way to turn a passion into an income, but they are governed by different rules than commercial businesses. Before you invest time and money, or take a misstep that's hard to undo, we encourage aspiring entrepreneurs to come talk to us. We're here to help guide you through the process and set you up for success.

The biggest thing to know is that home-based businesses are not commercial uses. They must remain clearly secondary to the residential use of the home. This means the business must be contained entirely within the dwelling and must not change the residential character of the neighbourhood.

In practical terms, this means:

- No outdoor storage of materials, products, or equipment
- No noticeable increase in traffic or parking related to the business
- No attractants or activity that draws attention to the property



- No outside indication that a business exists, including signage (home-based business signage is either very limited or not permitted, depending on the situation—always check first!)

If your idea involves food, there's another critical step: health approval through Island Health. Food production and sales have specific health and safety requirements that must be met before you operate.



We know these rules can feel discouraging, but they exist to protect neighbourhoods and business owners. Our goal is not enforcement—we truly dislike being the bearer of bad news. We want to help you understand the rules early, avoid costly mistakes, and find a path that works for both you and the community.



So before you get moving ahead, come in and chat with staff about your business idea. We can help you plan for success, and prefer to do so rather than having to step in later.

It's also essential for customers and purchasers to do their due diligence. Before buying goods or services—especially food—consumers should confirm that a business holds the proper business license and the required approvals. This helps protect consumers and supports responsible, compliant local companies.
